

PAB Meeting 2/28/17

- Early Head Start and Head Start -- 581 children received a Fluoride Varnish application (July 16-Feb 17)
- Bright Smiles for Babies (BSB) in WIC – 770 (403 Pregnant) Women received Education; 437 (262 pregnant) women received an oral screening; 2320 Children received a Fluoride Varnish application (July 16-Jan 17)
- BSB Medical Provider Trainings – 11 trainings have been conducted across 7 VDH Health Districts. (July 16-Jan 17)
 - This including 5 Private Practice offices; 4 Community Health Centers'. Providers trained: 30 doctors; 2 Physician's Assistants; 15 Nurse Practitioner's; 42 RN/LPN's; 10 auxiliary staff being trained in the BSB Program
- Basic Screening Survey WIC for Pregnant Women-559 completed out of the 600 goal. 4 locations remain to be completed. (July 16-Jan 17)
- Attended the Virginia Head Start Organization (VAHSA) Health Advisory Board meeting 1/18/17. Follow-Up email to the advisory board is attached detailing the remote staff available to coordinate dental education and fluoride varnish.
- Attended VAOHC Meeting about the Individuals with Special Health Care Needs Projects being conducted in 5 health regions. The first occurred Feb 9-11th.
 - *The Virginia Department of Health (VDH), in collaboration with the Virginia Dental Association Foundation (VDAF), Virginia Oral Health Coalition (VAOHC), Department of Behavioral Health and Developmental Services (DBHDS) and VCU Pediatric Dentistry Department, is starting a PHHS grant funded **Oral Health Care Access for ISHCN** project.*

 - *Target audience: medical/dental and lay health professionals; educators; caregivers; self-advocates; community organizations; DSPs; and anyone working with ISHCN*

 - *Friday 8:30 a.m. – 4:30 p.m.*
 - *Saturday 8:30 a.m. – 12:30 p.m.*
 - *Target audience: dental professionals (a limited number of interested physicians and/or nurses are welcome to attend)*

I just wanted to update you on the activities of the Remote Supervision Hygienist (RSDH) working for VDH. There are 10 RSDH and these hygienists are approved to provide preventive dental services under the direction of Virginia Department of Health, Dental Health Program. They are available to provide the following:

- Oral Health Education to parents and classroom teachers
- Dental screenings (this is not a dental exam)
- Fluoride varnish applications
- Nutrition Education as it pertains to Oral Health
- Oral Health Education for Pregnant Women
